

Civil War Slave Compensation Claims: 18th U.S. Colored Infantry (USCT) Index of Claims by Soldiers'/Former Slaves' Names



The following is a name index to slave compensation claims found in microfilmed Compiled Service Records of U.S. Colored Troops (USCT) that are available in the Special Collections Department and were purchased by the [Julius K. Hunter and Friends African American Research Collection](#). This index is alphabetical by the surname name of the soldier/former slave, then by his given name, and then by name of the former slave owner. An alphabetical [list by the former slave owners' names](#) is also available on the Special Collections' Web site.

Each entry includes the National Archives (NARA) microfilm publication number, roll number, and beginning frame number. To find the claim, locate the microfilm set, the specified roll, and then advance to the designated "beginning frame," which will be the first document of that soldier's compiled service record. To then find the slave compensation claim, read through to the end of his service record where documents for such claims consistently appear. The frame number is the number which appears between the upper edge of the film and the top of each document.

Note: When the name of a recruit or slave owner was spelled more than one way, entries have been made for the variations.
