Upgrade your old library card now



Out with the old (above) and in with the new.



Patrons who have white library cards with eight-digit numbers are now required get new cards with ten-digits. Due to software upgrades, the library's computer system now only recognizes ten-digit card numbers. That means the old, white eight-digit cards will no longer work for

checking out books, accessing account information, using the library's online databases at home, or printing in the Special Collections Department. To get a new card, stop by any St. Louis County Library branch and present your old card and a photo ID. Blue library cards are still valid and do not need to be replaced.

The set features abstracted slave records from deed books such as emancipations, “free papers” or affidavits of character, deeds, bills of sale, powers of attorney, schedules of separate property, pre-marital agreements, bonds, wills, and other gifts of slave property. Scottish monumental transcription books provide a unique genealogical resource

Those who are researching Scottish ancestors could be in luck. Discoveries await in the volumes of Scottish monumental inscription books now available in Special Collections Department. Published in Scotland, these books are rarely available in U.S. libraries. Of the more than 400 titles in the collection, the St. Louis County Library is the only institution listed as owning 250 of them, according to the Online Computer Library Center (OCLC), whose [WorldCat](#) database includes the holdings of most U.S. libraries. Monumental inscription books are, as the name suggests, transcriptions of texts inscribed on tombstones and other monuments to the dead, such as memorial plaques, war memorials, and church monuments. While some inscriptions are brief, many offer detailed information. The following are some examples:

■ “John FAIRLIE Wright, w Jean MORRIES. 1776” (From *Renfrewshire Monumental Inscriptions [Pre-1855]*, Vol. 1, p. 59, call no. R 941.439 R412)

■ “In memory of JOHN HOPE late tenant in New Mill who died 6.7.1810 aged 65 years and ISABELL HOPE his spouse who died 10.7.1829 aged 65 years also four of their children who died young. Likewise JAMES HOPE their son who died 15.1.1832(?) aged 25 years also JOHN HOPE their son late farmer in Plowlands who died 3.11.1847 aged 53 years also ADAM HOPE their son surgeon Jedburgh who died 22.11.1852 aged ? years.” (From *Roxburgh: Roxburghshire Monumental Inscriptions*, Vol. 9, p. 32, call no. R 941.37 R887)

■ “(broken in 3) Here lies Henry THOMSON miller Broadmill d 10.7.17[3]2-- , w Christian [JOHNST]ON d. -- .17—age 45y, also five of their chn. Also David & Christon chn to John THOMSON miller Broadmill wo d 8.3.1796 53 (w Alice WALLACE 28.9.181[6] 7[3]y). Here lies Peter --- --- d 9.1826 aged --y. (marginal) Here lies C[atherin]e HENDRY, h Henry THOMSON late miller Broadmill, she d 2[0].9.1802 35(Ed: per IGI-*they md Oldhamstocks 5.1791*)” (From *East Lothian Hillfoot Villages Monumental Inscriptions*, p. 49, call no. The volumes also commonly offer cemetery and locality maps, historical data, photographs of cemeteries and churches, and sources of other genealogical information.

To find a volume dealing with a specific locality, visit the [St. Louis County Library's online catalog](#) and do a keyword search for the words “inscriptions” and “Scotland.” Browse the list, or search by adding a specific place name as a third keyword. [URL: <http://webpac.slcl.org>]

The Department's monumental inscription books (with a few exceptions) are reference copies that do not circulate. Researchers who cannot visit the Department in person can access the information by requesting a lookup as follows:

- Search the library's online catalog to determine a book of interest. Most books include surname indexes.
- A lookup request must state the individual's name and the specific monumental inscription book to search.
- Patrons may ask for up to three searches per request by written letter or by e-mail to sollections@slcl.org. Emails should include a postal mailing address.
- If the requested information is found, copies of appropriate pages will be sent by U.S. Post along with an invoice for 15 cents per photocopy plus a \$1 processing fee.
